Clifford also participates in a wide range of government, community and philanthropic work in Hong Kong, including a member of the market development committee of the Financial Services Development Council and the investment committee of the West Kowloon Cultural District Authority; a director of the Hospital Authority's Tseung Kwan O Hospital and St. James Settlement; and a partner/mentor of technology incubator The Capital Factory (Austin, Texas).
